# **Enhancements & New Features**

The .29 release includes many new capabilities for the EVO Snap\* platform, as well as multiple smaller enhancements:

### 1. EBT Support

Several additions were made to the NGTrans Adapter to allow for several new areas of EBT functionality. EBT processing is supported for the Retail industry, and may be used for SNAP (Supplemental Nutrition Assistance Program or food stamp) or cash purchases.

### 2. Multi-partial Capture Support

Multiple-partial capture capability was added for MOTO, Ecomm, Retail, and Restaurant credit transactions. Multiple-partial capture processing refers to the process of submitting multiple partial Capture() transactions against a single approved Authorize() transaction for split shipment transactions.

### 3. Order Update Support

New Order Update transaction capability was added to credit transactions. Order update is used to add non-financial data to an approved AuthorizeAndCapture() transaction before the batch is closed. For NGTrans, Order Update may be used to add Level 2 and Level 3 data, and/or a product identifier for B2B enrichment purposes.

### 4. Commercial Card Support

Updates have been made to the EVO Snap\* platform to support Business to Business (B2B) commercial cards for NGTrans.

### 5. Additional Wallet Support

NGTrans has added support for digital wallet transactions. A digital wallet refers to an electronic device that allows a cardholder to make Ecommerce transactions using services such as Apple Pay, Android Pay, MasterPass, SamsungPay, DiscoverProtectBuy, AmexSafeKey, and JCBJSecure.

### 6. Version Control Value

Updates have been made to the EVO Snap\* platform in order to be able to validate the VersionControlValue (VCV) prior to passing the transaction to NGTrans.

### 7. Merchant Initiated Batch Close

NGTrans now has Merchant Initiated Batch Close capability and, when run, will return a decline or success along with the batch ID.

### 8. Four F Padding

With the Sterling integration to Snap\* supporting terminals, modifications needed to be made in order to support the new HEX 16 format alongside the HEX 20 format of KSN key lengths, specifically the manual addition of four "F"s to the front of the KSN. Thus, the Snap\* platform can now successfully decrypt the PIN block and then re-encrypt that PIN with the NGTrans Host PIN encryption keys.
