CWS Updates

Enhancements & New Features

The .30R2 release includes many new capabilities for the EVO Snap* platform, as well as multiple smaller enhancements:

1. Updates to Support Card on File Data

Front-End/Market: United States (NGTrans), Europe (eService)

Updates were made to the EVO Snap* Platform to begin support for CardOnFile data for the NGTrans and eService DSPs. For more information, please see the [NGTrans DSP](#) release notes and/or the [eService DSP](#) release notes.

Note: Merchants boarded before this release will continue to receive tokens on their transaction responses. All newly boarded merchants that want tokenization need to have the PurchasedTokenization flag set on their profile for tokens to be returned on responses.

2. SubscriptionReferenceId Added To Query Invoice Response

Front-End/Market: United States

A SubscriptionReferenceId has been added to the Query Invoice response in Dashboard so that a merchant can easily identify whether an invoice is stand alone or associated with a subscription.

3. New Indexes Added to Improve Server Performance

Front-End/Market: All Markets

New indexes were created to help improve Snap* database server performance.

4. 3-D Secure Information Added to Transaction Response

Front-End/Market: All Markets

3-D Secure information from the PayerAuthenticationResponse field has been added to the transaction response so that merchants can make a more informed decision on how to best proceed with the transaction. New details added are CAVV, XID, and Status that have been parsed from the PaRes. These new details are available on the Resubmit() response and on the QueryTransactionsDetail() response
