Enhancements & New Features

The .35R6 release was focused on enhancing support for 3-D Secure 2.0 in Europe:

3-D Secure 2.0 Enhancements

3-D Secure 2.0 Fallback

If a Merchant wants to run a transaction through 3-D Secure 2.0 authentication but isn't allowed to due to lack of support by the issuer, the Platform will downgrade the level of authentication to 3-D Secure 1.0 or Attempts Server. Data Only Authentication

Data Only Authentication will no longer require that the card exists in the CardRange. Thus, if BankcardTransactionData/ThreeDSData/ProcessAsDataOnly = true, there is no need to check if the card exists in the CardRange.

Default Required Visa Fields

If not set on the original Authorize or Authenticate Request, the following fields will have new default values:

- 1. TransactionType Default to GoodsServicesPurchase
- 2. RequestorChallengeIndicator Default to NoPreference
- 3. RequestorAuthMethod Default to None

AcquirerBIN to use MerchantBankld field on MerchantProfile or ThreeDSMerchantData

Because AcquirerBIN will be different for the different card brands, the existing MerchantBankId under the CardBrandIdentifiers object will be used to set the AcquirerBIN field on the Authorize request for the Full Flow workflow. For As a Service, the AcquirerBIN field under ThreeDSMerchantdata for will continue to be used for 3-D Secure 2.0. The fallback will continue to use MerchantBankId.

Convert CountryCode to ISO Digit

Updates were made to ensure all CountryCodes correspond to a three-digit ISO code on the Authorize or Authenticate request.

Other Platform Enhancements

Handle Account Updater Response Files Only Containing Positive Matches

Instead of assuming an error occurred if the Card Brand does not return the UpdatedAccountData or UpdatedTokenData on the response, Snap will now assume the account was verified if there are no other errors on the request.
